ONEIDA COUNTY TRUCK DRIVER CHARGED WITH PERJURY AND DEFRAUDING WORKERS' COMPENSATION AND NEW YORK STATE

SYRACUSE - New York State Inspector General Catherine Leahy Scott today announced the arrest of an Oneida County trucker, who recently took a job with New York State, on charges he falsified hearing testimony, falsified documents submitted as part of his job application with the State, and defrauded the Workers' Compensation system while receiving nearly \$8,000 in insurance benefits to which he was not entitled.

Roger M. Decker Jr., 48, of Lee Center, was arrested and charged today with Falsifying Business Records in The First Degree, Offering A False Instrument for Filing in The First Degree, Insurance Fraud in The Third Degree, Perjury in The First Degree, and Grand Larceny in The Third Degree, all felonies.

An investigation by Inspector General Leahy Scott found that Decker was injured while working for an Oneida County trucking company in 2004 and shortly thereafter stopped working and started collecting Workers' Compensation benefits. The charges allege that Decker repeatedly submitted falsified forms to the New York State Workers' Compensation Board (WCB) and his physician in 2016 and 2017, and that he testified at a WCB hearing that he had not worked for more than a decade when he was in fact working for at least two trucking companies. In total, Decker is charged with receiving \$7,875.08 in Workers' Compensation benefits in 2016 to which he was not entitled.

Additionally, the investigation found that Decker falsely indicated that he had never been injured while on the job in documents submitted in late 2017 as part of his job application for highway maintenance worker position he obtained with the New York State Department of Transportation.

"This defendant repeatedly concealed his work history and testified falsely under oath as part of a multi-faceted fraud against the Workers' Compensation system and the State of New York," said Inspector General Leahy Scott. "I will continue dedicating the resources of my office to protect the integrity of the state's vital Workers' Compensation system."

Under State law, Workers' Compensation wage replacement benefits are for those who have sustained a work-related injury limiting their ability to work.

Decker was arraigned on the charges and released on his own recognizance pending further court action.

Inspector General Leahy Scott thanked the New York State Police for their assistance with the arrest, and Oneida County District Attorney Scott D. McNamara and his office for prosecuting this matter.
